3. Guidance for Candidates

1. Completion and deadline for submission of nomination papers

The Notice of Election will be published on 16 March 2023. This means that nomination papers (with a completed consent form) can be delivered to the Returning Officer (c/o Electoral Services team) between the hours of 10am to 4pm from Thurs 16 March until 4pm on Tues 4 April.

- Home address form if you do not want your home address to be published on notices & ballot papers complete Part 2 of the form. If you choose to withhold your home address, your address will be shown as "Address in Swale" and NOT the parish name.
- Please note that when submitting the 1c Consent to nomination papers, you must submit all of the papers with it (pages 1 − 5) otherwise the consent will not be valid.
- Please arrange a time with the Elections team for an informal check of your nomination paper before submitting the final forms. For an informal check, you can email your nomination papers to elections@swale.gov.uk or call 01795 417558 to arrange an appointment. If you do not arrange an informal check and don't submit your nomination papers early, there may not be time to correct any errors before close of nominations, given the number of nomination papers that will be received in a short period of time (there are also Borough elections on the same day).
- Please read the checklist at the front of the nomination papers, as there have been some changes to legislation since last elections. The final nomination papers must be delivered BY HAND to Swale Borough Council, Swale House, East Street, Sittingbourne, ME10 3HT before the deadline of 4pm on 4 April 2023

There is some guidance set out on the reverse of the nomination paper which you need to read. Additional guidance is provided below which is applicable to parish/town council nominations:-

- Those supporting the nomination paper (i.e. the proposer and seconder) must be registered
 as an elector in the same parish (or parish ward if applicable) as the election, at the last
 date of publication of the Notice of Election. This means that they must be on the electoral
 register as at 1 March 2023.
- Each elector may only subscribe as many nomination papers as there are vacancies in the parish. For example, in the case of a parish or town ward with one vacancy, an elector may subscribe to one nomination paper in that ward. In the case of a parish or town ward with

two vacancies, an elector may subscribe to two nomination papers; if there are three vacancies, an elector may subscribe to three nomination papers etc.

- Please note that there is an option to include a 'commonly used name' which will appear on the ballot paper and notices, and to ask for your home address not to be shown on the ballot paper and notices.
- You can also include a description if you wish of up to six words. This can be the word 'independent'; a description of your rank, profession or calling; or a registered political party if you have the appropriate authorisation (see 2 below). Alternatively you may leave the description blank. Please note that whatever description used will appear on all official notices and the ballot paper.
- In respect of the consent form, please note that you are required to provide your date of birth. The witness who signs the consent form must be the same person who attests the home address form. The consent form must be dated within one month of the deadline for the nomination papers.

2. Standing for a political party

If you wish to stand for a political party, you will need approval of the appropriate registered political party (signature of the party's registered nominating officer, or person authorised by the nominating officer). The candidate also needs to give authorisation to use the party logo. A form is enclosed for this purpose which must be handed in no later than 4pm on Tues 4 April with your nomination papers.

3. Appointment of agents

There is no facility for you to appoint an Election Agent. However if the election is contested you may appoint postal vote agents (to observe the postal vote opening), polling agents (to observe in the polling station) and counting agents (to observe at the count). These will need to be made in writing and forms for this purpose are available from Electoral Services. Please note the deadline for polling and counting agents is 26 April. Postal vote agents must be appointed prior to the opening sessions.

4. Election expenses

All candidates are required to complete election expenses, regardless of whether or not the election is contested, and even if a nil return. Parties that have more than one candidate in a ward standing for election are considered joint candidates. Where there are two joint candidates, the spending limit for each candidate is reduced by a quarter, and where there are three joint candidates the spending limit is reduced by a third for each candidate.

Please note that the spending limit for candidates standing in local government elections in England and Wales is £806 plus a variable top-up of 7p per elector in that electoral area.

Electorate levels per Parish, Parish Ward and Town Ward will be available after 1 March and expense forms can be downloaded from the Electoral Commission website. Please note that you

5. Voter ID, registering to vote, postal/proxy voting and electoral register

Voter ID – you will be aware that for the first time, voters will have to show eligible photo ID (e.g. drivers licence or passport), when voting in polling stations, from 4 May 2023. This is in addition to being registered to vote. If voters don't have their own photo ID they can apply, free of charge, for a **Voter Authority Certificate (VAC)** online at:

When applying for a VAC voters will need to:

- a) Be registered to vote (or make an application at the same time at www.gov.uk/registertovote)
- b) Will need to know their National Insurance Number and Date of Birth
- c) Have a clear digital photograph of themselves (head and shoulders) to upload with the application

If voters don't think they have acceptable photo ID and aren't able to apply for a VAC, then they can apply to vote post or appoint a proxy to vote on their behalf (the proxy will need to show photo ID for themselves and also be registered to vote)

Registering to vote:

- Voters do not need to register to vote separately for the parish elections. If they are unsure whether they are registered or not, they can call 01795 417316 or email electors@swale.gov.uk and we can check.
- If they do need to register to vote, then the quickest and easiest way is online at www.gov.uk/registertovote
- Alternatively, they can complete a registration form. We can post out a paper form or a copy can be downloaded here:

Candidates can request a copy of the electoral register / absent voter list, in writing, and a form is enclosed for this purpose. Please be aware that there are strict rules governing the use of the register and that it must only be used for electoral purposes. Please note the earliest a candidate can receive a copy of the electoral register/absent voter list is **MONDAY 27 MARCH 2023**, unless they are otherwise entitled to receive one.

6. Candidate/Agent Briefing – Weds 12 April at 7am at Swale House, Sittingbourne

Borough Agents and Candidates acting as their own agents have been invited to attend a briefing about the election but Parish candidates are welcome to attend. Please make a note of the above date, and register your interest in attending with elections@swale.gov.uk. The briefing will also be available to attend online via MS Teams as well.

7. The Count

The venue for the Count is the Sports Hall at the Swallows Leisure Centre, Sittingbourne. The count will start at **9.30am on Friday 5 May**, and will begin with verification of the borough and parish/town ballot boxes, followed by the Borough count and then the count of parish/town council papers.

Please be aware that the Count process for Borough wards with two and three members will take longer than those for single member wards; and that there are likely to be a number of Parish and Town Council elections to count.

All results will be posted on the Council website after being declared.

8. Code of Conduct for Councillors

If you are successfully elected as a Parish/Town Councillor, you will be required to sign up to the Code of Conduct and register any interests that you have. More details of this can be viewed here: http://www.swale.gov.uk/councillor-codes-of-conduct/
